### Lisa 1 Arvestuspõhimõtted

#### Üldine informatsioon

The Company's Annual Accounts for the year ended 31 December 2023 have been prepared in accordance with Estonian Financial Reporting Standard. The Estonian Financial Reporting Standard is a set of financial reporting requirements for the public based on internationally accepted accounting and reporting principles, the basic requirements of which are established by law and supplemented by the guidelines of the Accounting Standards Board.

The financial statements are presented in euros.

#### Raha

Cash in hand and at bank are recognized as cash and cash equivalents in the balance sheet and cash flow statement.

#### Välisvaluutas toimunud tehingud ning välisvaluutas fikseeritud finantsvarad ja -kohustised

Foreign currency transactions are recognized using the official exchange rates quoted by the European Central Bank on the date of the transaction. Monetary assets and liabilities denominated in foreign currencies are revalued in the functional currency on the balance sheet date using the exchange rates quoted by the European Central Bank on the balance sheet date. Exchange gains and losses arising from revaluation are recognized in the income statement of the accounting period. Non-monetary assets and liabilities denominated in foreign currencies, which are measured at fair value, are revalued in the functional currency on the basis of the exchange rates quoted by the European Central Bank on the day when the fair value was determined.

#### Nöuded ja ettemaksed

Trade receivables, accrued income and other short and long-term receivables are recognized at the adjusted acquisition cost. The adjusted acquisition cost of short-term receivables is generally equal to their nominal value (less any write-downs) and therefore short-term receivables are recognized in the balance sheet in the amounts that are likely to be received.

#### Finantskohustised

All financial liabilities are recognized at the adjusted acquisition cost. The adjusted acquisition cost of short-term financial liabilities is generally equal to their nominal value and therefore short-term financial liabilities are recognized in the balance sheet in the amounts subject to payment.

#### Maksustamine

In accordance with the Income Tax Act in force in Estonia, corporate earnings are not subject to tax in Estonia. Income tax is paid on dividends, fringe benefits, gifts, donations, reception costs, disbursements not attributable to business and adjustments of transfer prices. The tax rate applied to profit distributed as dividends from 1 January 2015 is 20/80 of the net amount to be paid out.
