Activity Report of Balti Teedeliit / the Baltic Road Association for 2023

Balti Teedeliit / the Baltic Road Association (BRA) was established in 2014 as a non-profit organisation in Estonia. It continues co-operation of the Estonian, Latvian and Lithuanian Road Administrations, which started in 1989. It also serves as a successor of the co-operation which began already in 1932.

Key aim of the BRA is to seek possibilities for mutual co-operation, namely:

- To conduct joint studies,
- To co-ordinate the work of technical expert groups,
- · To organize seminars of mutual interest,
- To organize international road conference every four years,
- To participate, if needed, in the process of harmonization of the legislation in the EU road sector.
- To co-operate with other relevant international organizations.

The work of the non-profit Association is managed by the Council, which consists of the directors of the road adminstrations of the three Baltic states, deputy directors general or functional directors.

In addition to the Council there are 9 Technical Committees (TC) and Working Groups (WG) of the Association:

- 1. Administrative WG
- 2. Strategy WG
- 3. Construction TC
- 4. Design and research WG
- 5. Traffic Safety TC
- 6. Maintenance WG
- 7. Intelligent Transport Systems TC
- 8. Asset Management WG
- 9. Public Outreach WG

When Lithuania took over the BRA presidency, the intense period of the Covid pandemic had already ended. The live meeting format was successfully returned. Over the past year, though the activity level of TCs and WGs has slightly decreased. Committees and working groups had fewer meetings in person and online.

In 2023 two statutory meetings of the BRA Council were held in May and in December respectively. The meetings were mainly focused on country reports, subjects of specific current interest (military mobility, asphalt recycling, green procurement, etc.), as well as co-ordination of joint Baltic participation in few international events planned in 2024: conference "Transport Research Arena" and congress "Via Nordica".

The following physical meetings of TCs and WGs were held in 2023:

- Meeting of Design and research working group on May 8 10 with the focus on the system of condition surveys for bridges and viaducts, periodic calibration of road testing equipment and documentation of compliance, discussion of the possibility of periodic round robin tests of road testing equipment in the Baltic States and status update of BIM application for road project management,
- Meeting of internal auditors of Baltic and Nordic Road Administrations in Stockholm on May 10 – 12 with the focus on country reports and best practices in the procedures for internal audits,
